- Consider Resolution 152-2024 which is a resolution to adopt building permit fees. This item was tabled until the September 9th BMA Meeting.
- Consider Resolution 156-2024 which is a resolution authorizing the Town to participate in the Property Conservation Matching Grant Program. A motion was made by Alderman Mierek. The motion was seconded by Alderman Bishop. The Board was unanimous in favor of approving.
- Consider authorizing Fire Chief Shane Suthers and/or Denny Steele to apply for 2025 Volunteer Firefighter Equipment & Training Grant. A motion was made by Alderman Bishop. The motion was seconded by Alderman Mierek. The Board was unanimous in favor of approving.
- Consider authorizing Alderman Collier to apply for the Tourism Enhancement Grant Round
 7. A motion was made by Alderman Bishop. The motion was seconded by Alderman Hoss.

- Consider authorizing Alderman Bishop to apply for the BCBS Healthy Place Grant. A motion was made by Alderman Mierek. The motion was seconded by Vice-Mayor Jarnigan. The Board was unanimous in favor of approving.
- Consider accepting the donation from the Surgoinsville Medical Board to purchase a new double-sided sign at Surgoinsville Creekside Park. A motion was made by Alderman Bishop. The motion was seconded by Alderman Hoss. The Board was unanimous in favor of approving.
- Consider FY2025 Employee Raises. This item was tabled.
- Mark Osborne with The Lane Group provided an update & detailed explanation of the Sewer Extension to 11w. Osborne discussed 2 route options & stated that this is an all-pressure line. Easements for the route will need to be obtained for at least 20 feet. The Board will review these routes and did not select a route option at this time.
- Consider authorizing Chief Hammonds to discuss and obtain easements for the properties needed to complete the Sewer 11w Extension & also authorize Megan Gentry, Recorder, to assist as needed. This motion was made by Alderman Bishop. The motion was seconded by Vice-Mayor Jarnigan. The Board was unanimous in favor of approving.
- Discuss hiring a temporary CDL driver to work on Mondays & Tuesdays to assist with Maintenance Department due to a Full-Time Employee being out of work at this time. No motion or voting required per Attorney Joe May.
