- Oconsider the second & final reading of Ordinance 155-2021, which is an ordinance to amend the municipal zoning ordinance of the Town of Surgoinsville for the purpose of amending the table of contents, Article IV, Section 401, and Article VII, Section 703 to include R-3 District. A motion was made by Alderman Hoss. The motion was seconded by Alderman Collier. A roll call vote was obtained and was unanimous in favor of approving.
- Consider the second & final reading of Ordinance 178-2024 which is an ordinance regulating false fire alarms. A motion was made by Alderman Mierek. The motion was seconded by Alderman Bishop. A roll call vote was obtained and was unanimous in favor of approving.
- Consider accepting FY2023 Assistance to Firefighters Grant. A motion was made by Alderman Collier. The motion was seconded by Alderman Mierek. A roll call vote was obtained and was unanimous in favor of approving.
- O Consider the appropriate Budget Amendment for a minimum of 6% match of the FY2023 Assistance to Firefighters Grant estimated amount of \$30,000 to 110-42200-297. A motion was made by Alderman Collier. The motion was seconded by Alderman Hoss. A roll call vote was obtained and was unanimous in favor of approving.
- O Consider approving the bid specifications for the Surgoinsville Fire Department Mini Pumper to be published. Fire Chief Suthers requested that this item be tabled and the Board of Mayor & Aldermen agreed.
- O Consider declaring the Sterling Cascade/Compressor System at the Fire Dept as surplus. A motion was made by Vice-Mayor Jarnigan. The motion was seconded by Alderman Collier. Board of Mayor & Alderman unanimously agreed.
- Consider accepting Judy Housely Safety Partners Matching Grant through Public Entity Partners. A motion was made by Alderman Collier. The motion was seconded by Alderman Mierek. A roll call vote was obtained and was unanimous in favor of approving.
- O Consider authorizing Mayor Graham to execute the Agreement to Provide Fire Fighting Service to Phipps Bend Industrial Park. A motion was made by Vice-Mayor Jarnigan. The motion was seconded by Alderman Hoss. A roll call vote was obtained and was unanimous in favor of approving.
- O Consider authorizing Megan Gentry & Mayor Graham to open a new checking account for the \$5 e-citation fee. A motion was made by Alderman Mierek. The motion was

- seconded by Aldman Bishop. A roll call vote was obtained and was unanimous in favor of approving.
- Consider FY2025 Employee Raises & the appropriate Budget Amendment which will retroactively date to July 1<sup>st</sup>. A motion was made by Vice-Mayor Jarnigan that full-time employees, with the exception of a specified full-time Police Officer, will receive a 5% hourly wage increase effective July 1<sup>st</sup>, 2024. Additionally, full-time employees with an active Commercial Driver License will receive a \$1 hourly wage increase effective July 1<sup>st</sup>, 2024. The motion was seconded by Alderman Mierek. A roll call vote was obtained and was unanimous in favor of approving.
- Oconsider route Option #1 & Option #2 for the Sewer Extension to 11w. A motion was made by Alderman Mierek to approve Option #1 for the Sewer Extension to 11w via Virginia Hills subdivision. The motion was seconded by Alderman Bishop. A roll call vote was obtained and was unanimous in favor of approving.
- Consider authorizing Megan Gentry to open a LGIP account for the Drug Fund. A
  motion was made by Vice-Mayor Jarnigan. The motion was seconded by Alderman
  Collier. A roll call vote was obtained and was unanimous in favor of approving.
- Oconsider accepting the 3-year donation of land to apply for the BCBS Healthy Place at 1293 Main Street from First United Methodist Church of Surgoinsville. A motion was made by Alderman Bishop. The motion was seconded by Alderman Mierek. A roll call vote was obtained and was unanimous in favor of approving.
- Consider the appropriate Budget Amendment to purchase a dehumidifier & blinds for the Little House and a dehumidifier, blinds, & microwave for City Hall. A motion was made by Alderman Collier with adding to inquire with Travis at MTAS about utilizing the funds encumbered from FY2024 for City Hall repairs. The motion was seconded by Alderman Mierek. A roll call vote was obtained and was unanimous in favor of approving.

# **COMMUNITY INTEREST ITEMS**

- Mayor Graham provided an update from the Dr. Lyons & Riverfront Festival on Labor Day weekend and thanked everyone that helped. Mayor Graham stated that the last 2 musicians and the Fireworks were rained out. Mayor Graham suggested rescheduling a weekend event for the Fireworks. Fire Chief Shane Suthers will work to coordinate with the pyrotechnics company.
- Alderman Mierek stated that she will be organizing free meals for the community through Surgoinsville Community Kitchen. This is a nonprofit & will function by donations. The first meal for the community is scheduled September 30<sup>th</sup> and will take place at 1034 Main Street, which is the Little House between the Surgoinsville Elementary & Surgoinsville Middle schools.
- Alderman Collier inquired about an update for road repairs in Stewart Landings and throughout the town. Donnie Morrison, Maintenance Manager, stated that the roller is currently in need of repair and is not functioning properly. Morrison obtained quotes for renting a roller until the repair is complete and estimates an expense of \$400 for a one week's rental. Morrison expressed concern with number of employees working and stated that having someone to temporarily drive the Monday and/or Tuesday trash routes would be very beneficial to ensure that roads are able to be repaired. Road repairs require 3 of
